Registration

A completed registration includes:

1. A non-refundable Application Fee of \$150 payable to Kells Academy.
2. A completed and signed Application Form and International Student Contract.
3. School report cards from Grades 9, 10 and 11.
4. A Birth Certificate or Household Registry stating the name of the student, the father's name and the mother's full name including her maiden name.
5. Copy of Passport, Immunization/vaccination records and photograph.

Payment Due Upon Acceptance:

A completed and signed registration form with a deposit of \$2,100 CDN funds is required before a letter of acceptance will be issued (includes Admission Fee, Supplies/Technology Fee and Medical Insurance). If the student possesses a personal insurance policy, the deposit is \$1,150. Methods of payment: Cheque, Wire Transfer or e-transfer.
